It will be the responsibility of every coach, skater, and employee to do their part to ensure that the **Wonderland of Ice (WOI)** remains a clean and safe environment. As public health concerns decrease, and capacity/operating restrictions ease, policies will be reviewed and updated. Skaters and coaches will be notified of any changes prior to implementation.

Wonderland of Ice will implement the following recommendations based on the Center for Disease Control and Prevention's (CDC) social distancing and sanitation practices to mitigate the spread of the coronavirus and to provide safe and comfortable environment for our customers and staff.

FREESTYLE GUIDELINES

Registration Process:

- Upon confirming lesson schedule with Coach, skaters are required to register in advance at LAFWONDER@aol.com. **COVID waiver must be signed before first session skated.**
- Session Prices (60 minutes):
 - \$40 per skater per session / \$30 per skater per session Bridgeport Skating Club members
- (90 minutes):
 - \$50 per skater per session / \$40 per skater per session Bridgeport Skating Club members
 - Cash or checks only due before start of the session

Credits for subscribed Spring 2020 sessions cancelled, will be offered as a cash credit towards the purchase of Summer 2020 sessions. No exceptions.

Session Rules:

- Social distancing of at least 6 feet apart will remain in place for ALL areas of WOI
- Required face mask or covering worn by ALL individuals (skaters, coaches, and parents) while on the property
 - Skaters may choose to wear a mask ON-ICE; however, it is not required.
- All warmups must be done outside and prior to entering the rink.
- Skaters are permitted to enter the rink 15 minutes before their scheduled session and are required to leave the building 15 minutes after the completion of the session.
- Before entering everyone will undergo a temperature and health screening.
- Arrive at the rink in all necessary attire (except skates).

- Put skates on in designated areas of the rink, marked with social distancing dots.
- We urge parents to drop off and wait outside or in your car. Only parents of skaters age 11 and under, needing assistance may enter the rink.
- Parents must remain seated in the bleacher area until their child is ready to leave the building. Social distancing required.
- Skaters are to enter and exit the ice surface through designated lobby doors only.
- Use the full ice: stay away from others; limit coach and skater personal interactions.
- ONLY Rink Music system scan tags will be used. No personal devices permitted.
- Harness will not be in use until further notice.
- Players and scorer's boxes use will be prohibited.
- Locker Room use will be prohibited.
- Please limit personal items brought to the rink. Leave all personal items in your skating bag.
- Arrive with full water bottles. Water fountains have been temporarily disabled.
- No personal items may be left on the top of the rink boards.
- No items are to be spread out across the bench areas to avoid close contact with others.
